AFFIDAVIT OF CHARLES A. GRYMES IN SUPPORT OF THE COALITION TO PROTECT  
PRINCE WILLIAM COUNTY'S MOTION FOR REHEARING OR RECONSIDERATION

The undersigned, Charles A. Grymes, of Manassas, Virginia, having been duly sworn on oath before a Notary Public, states the following:

1. I serve as a consulting party to the procedures regarding CENAO-2006-01343, a proposal by VADATA, Inc.(Applicant), Attn: Ian Wrightson, 410 Terry Avenue, N, Seattle, WA 98109 to enter into a Memorandum of Agreement (MOA) with the US Army Corps of Engineers (Norfolk District) and Virginia Department of Historic Resources under Section 106 of the National Historic Preservation Act.
2. I was in attendance at the March 8, 2017 meeting of the Midwood Consulting Parties meeting held at the Fredericksburg NPS Maintenance Facility, 207 Freedom Court, Fredericksburg, VA 22408.
3. I was surprised to discover at the March 8, 2017 meeting from Attorneys from Williams Mullen representing the Applicant of the Midwood Consulting Parties that the Applicant had cleared the entire property, and that the whole site had been cleared to accommodate a staging area for the building materials and equipment required to construct building number one.
4. I was also surprised to be told by the attorneys for the Applicant that a new transmission line was not required for the initial development because Building One is complete and operational using the existing electrical utility infrastructure, and even Building Two would operate without the requirement for additional electrical utility infrastructure.
5. An additional revelation from the attorneys for the Applicant was that the electric transmission and distribution facilities delineated in Dominion's application (CASE NO. PUE-2015-00107) would not be required until such time as Building Three was operational, and that Buildings Two and Three were not projected to be built in the

foreseeable future as construction would only occur if expanded capacity were required in the future by the Applicant.

6. Based on comments by attorneys for the Applicant, it is clear that construction of a new 230 kV line transmission line by Dominion will be triggered by construction of Building Three, and the Area of Potential Effect for the Section 404 permit should consider the entire route of that transmission line.

This Affidavit is being presented in connection with the Coalition to Protect Prince William County's Motion for Rehearing or Reconsideration in the captioned Application. I am familiar with the nature of an oath and with the penalties as provided by the laws of the Commonwealth of Virginia for falsely swearing to statements made in an instrument of this nature,
