NOTICE OF PARTICIPATION OF RESPONDENT SOUTHVIEW 66, LLC

COMES NOW the Respondent Southview 66, LLC ("Southview 66"), a Virginia limited liability company authorized to do, and doing, business in the Commonwealth of Virginia, by counsel and, pursuant to SCC Rules of practice 5 VAC 5-20-80-B, states as follows:

- 1. Southview 66 is the owner of approximately 110 acres consisting of two properties (the "Property") located in the southwest quadrant of the Interstate 66/Route 29 interchange in the Gainesville Magisterial District of Prince William County (the "County"). The Property is more particularly identified as GPIN 7397-65-0196, with the mailing address of 14300 John Marshall Highway ("Parcel One") and GPIN 7397-75-7977, with the mailing address of 13714 Daves Store Lane ("Parcel Two"), both in Gainesville, Virginia 20155.
- 2. Southview 66 is an electric rate payer and is an interested party in the instant proceeding within the meaning of "interested parties" as set forth in Va. Code Ann. § 56-46.1 (D). Southview 66 is in the late stages of finalizing the design of a retail center (the "Development") on the Property.
- 3. Virginia Electric and Power Company, doing business as Dominion Virginia Power ("Dominion") has requested approval from the State Corporation Commission (the

"Commission") for a 230 kV double circuit transmission line loop as well as a 230-34.5 kV substation ("the Proposed Substation"). Dominion has identified the I-66 Overhead Route ("Proposed Route") and four alternative routes for a total of five routes for the transmission line, with all of the routes, except the Proposed Route, either crossing the Property or coming very near the Property.
